ONE Galveston, Proposition, 2 Options Shall the city council of the city of Galveston, Texas (the "city") be authorized to issue bonds of the city, which may be called city of Galveston, Texas, public improvement bonds, in the amount of \$62,000,000 for the purpose of the construction, acquisition, improvement and rehabilitation of streets, bridges, storm sewers and drainage, including curbs, gutters, sidewalks and other related public infrastructure, traffic systems and the acquisition of rights of way relating to such projects, said bonds to mature serially or otherwise at such times as may be fixed by the city council not to exceed forty (40) years from their date or dates, to be issued in such installments and sold at any price or prices and to bear interest at any rate or rates as shall be determined within the discretion of the city council under laws in effect at the time of issuance, and to provide for the payment of the principal of and interest on said bonds and the costs of any credit agreements by levying a tax upon all taxable property in the city sufficient to pay the annual interest on and to create a sinking fund sufficient to redeem said bonds as they become due?
